This is intended to reach agreements on the event-related data collection system, design elements that create the "look and feel" of the event, the name of the event, the elements of the event that will transform event proponents and attendees, further direction to the SIAC Subcommittee and the Outreach Subcommittee regarding outreach for the event, and assist in the understanding of the ways that Stratus may assist in the handling of proposals received in the SIAC process.

The review and discussion are intended to reach an understanding of the historic record of the relationship between water demand and growth and an agreement on the parameters that the Committee will follow when considering growth.
