

## The Regional Water Authority Plan (/initiative/4WpX/the-regional-water-authority-plan)

This plan would create the Santa Cruz County Water District. It would function identically to the Santa Clara Valley Water District, which is responsible for ground water and wholesale of raw and recycled water to the other water agencies (retailers) in the county of Santa Clara. While it would not produce water directly, this proposal would make it easier for the 6 existing water agencies in Santa Cruz County to work together on large projects such as recycled water and aquifer recharge. Particularly it would enable the construction of a water sharing utility corridor along the Rail Trail.

One last thought on this subject, relating to a large district or coordination. My graduate studies were in collaborative governance and I have put them to good use over the years. I also feel very strongly about small local government being the best means of citizen representation. From this basis I would just like to point out that collaboration doesn't require consolidation. It's done well in many places. At my previous District we received statewide recognition for our long time collaborative efforts with two neighboring cities and the county. All four entities

were very different and very different infrastructure needs, but we came together on things we all needed such as a jointly owned treatment plant. Someone in midcounty isn't the best person to tell San Lorenzo what they need to do to fix their problems and vise versa. But there are many areas where we can work together on joint needs. This hasn't been done so well here in the past in my outsiders opinion, but I'm starting to see some real changes.

There is already a JPA for management of the mid county basin. In the past year collaborative efforts have been made to prepare to restructure the JPA into a Groundwater Management Authority with representation of all groundwater pumpers. The county accepted a position and the City of Santa Cruz and Pajaro Vally Water Management Agency have also been extended invitation to join the current Soquel Creek, Central Water District and private well representative members. Through a stakeholder process, a structure will be identified that will allow the mid county area to meet the new state requirements for a twenty year groundwater sustainability action plan. They would need a huge capital investment somehow to get started, and they would meter and wholesale this water to all the smaller water agencies the same way, for example SCVWD sells water to San Jose Water. Not sure what assets you are talking about, but all the existing water and waste waste infrastructure would have the same ownership. Also not sure about what you are saying about a Director stepping down. This would be an entirely new Special District, with Directors being required to be a customer of each major water agency.
